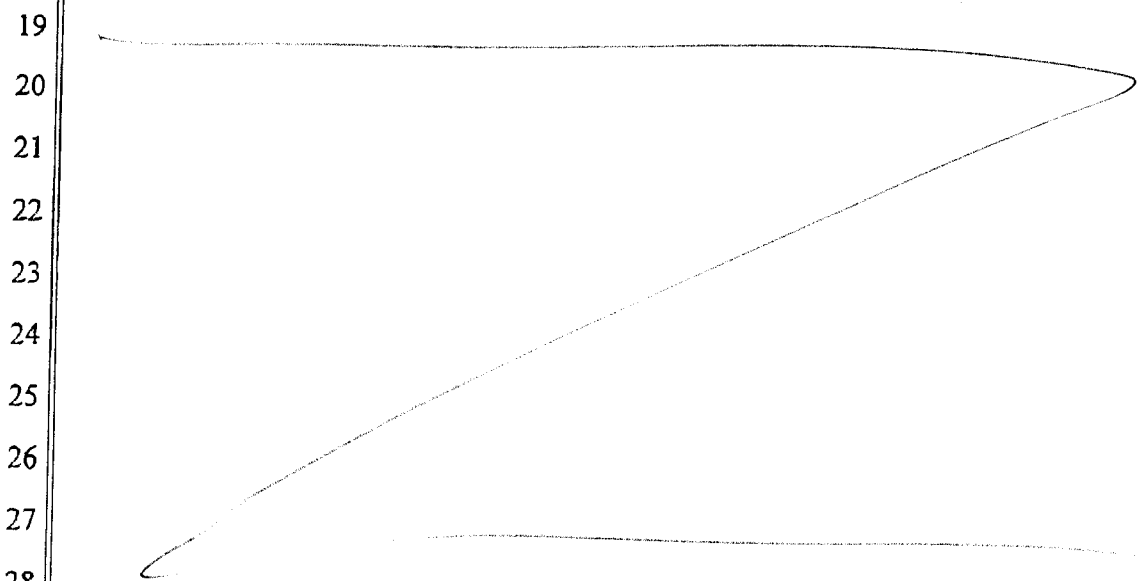




1 On June 20, 2005, the court of appeal reversed judgment in favor of petitioners and
