Special Order 2020-7

In order to address the global coronavirus pandemic and the concomitant public health concerns, Circuit Court of Cook County General Administrative Order 2020-1 (as amended May 1, 2020) provides for the continuance, with certain exceptions, of all cases pending in Circuit Court of Cook County. Within the Child Protection Division the exceptions are limited to Temporary Custody Hearings and Emergency Motions.
